# MINISTER'S COMMITMENT TO FINDING A SOLUTION

AT THE END OF THE RECENT COMMUNITIES & LOCAL GOVERNMENT CONSULTATION ON HMOs, A GOVERNMENT SPOKESPERSON SAID:

"Students bring benefits to the places they live in, but too many residing in one area can impact negatively on a community, running down neighbourhoods and leaving places as ghost towns during the summer.

"This is a real problem in many communities across England, which is why Communities Secretary John Denham is committed to finding a long term solution to current rental practices."

John Denham's Southampton constituency experiences the same problems with HMOs as Nottingham does and he has campaigned on these issues all his parliamentary career, regularly arguing that the planning rules governing HMOs need to be improved.

Speaking at the publication of the ECOTEC Report on HMOs last September, he said: "Over the years I have often been frustrated by the unwillingness of too many people to accept that some towns and cities have a real problem. Students make a significant contribution to sustaining and regenerating communities. But their dramatic growth in recent years has seen this type of housing problem increase because students typically group together to rent properties.

We understand he is hoping to make a statement about HMOs and possible planning responses in late summer.

There will be more about the consultation in the next issue of the NAG magazine.

## NOTTINGHAM'S CORE STRATEGY CONSULTATION

AT THE RECENT CORE STRATEGY CONSULTATION MEETING AT ST. MARY'S CHURCH HALL, RESIDENTS MADE THEIR VIEWS KNOWN ABOUT WHAT THEY want to see in Nottingham's developing Core Strategy.

Top of the list of concerns was shared houses (HMOs) and the way in which they affect our neighbourhoods today, and what has to be done to make sure that in the future our neighbourhoods will be places where families will want to live.

Strong views were expressed about the need for Nottingham's universities to do their bit by building student accommodation on their own campuses.

Also highlighted was the need for good schools, good amenities and good-quality housing to stop existing families from moving out of the city, and attract new families into Nottingham.

#### MORE ABOUT THE CORE STRATEGY

After the meeting, the NAG was sent a number of comments by residents about the Core Strategy. These have been forwarded to the City Council along with a formal response on behalf of the NAG. Arrangements are being made for a further meeting with the council officers responsible for developing the Core Strategy and the Sustainable Communities Strategy – hopefully in early November

### **BURGLAR ALARMS**

IN RESPONSE TO PROBLEMS THE NAG HAS RAISED THIS SUMMER ABOUT DISTURBANCE CAUSED BY BURGLAR ALARMS, NOTTINGHAM CITY COUNCIL'S NOISE AND Pollution Control team has asked us to pass on some information to you.

If residents can let the Pollution Control team have details of properties where alarms are sounding continuously for more than 20 minutes, or sounding for shorter periods and then resetting themselves and sounding again, etc., the team can at least send an advisory letter to the owner/occupier of the property.

Noise from alarms can be reported directly to the Pollution Control Team by calling **915-6410**. The team will look to identify and contact the owner to get the alarm silenced. Where necessary, they will take enforcement action to enable them to enter properties to disable alarms. At week-ends the answer phone is checked for messages about alarms and, again, the team will try and contact the owner and get the alarm silenced. However, you are asked to report sounding alarms to the Police as well as the Council in case the alarm is sounding because a burglary has been committed or is in progress.

### **CITY TAKES ACTION**

THE CITY COUNCIL IS CONTINUING TO TAKE ACTION ON LANDLORDS WHO HAVE FAILED TO COMPLY WITH THE PROVISIONS OF THE HOUSING ACT. In July, Dr. Balvinder Singh Mehat was fined a total of  $\pounds 20,534.06$  by the Magistrates' Court.

In addition to breaching HMO licence requirements and management conditions of one of his properties in Lenton, Nottingham City Council officers found that the property presented a significant fire risk to its seven student tenants.

More recently, Anthony Carroll of Highfield Road, Dunkirk, pleaded guilty to 17 charges relating to the management of properties he owns in Dunkirk.

The case has now been referred to Nottingham Crown Court.

### NOTTINGHAM UNIVERSITY STUDENT OPEN DAYS

ADVANCE NOTICE HAS BEEN SENT THAT NOTTINGHAM UNIVERSITY WILL BE HOLDING OPEN DAYS FOR PROSPECTIVE STUDENTS IN SEPTEMBER.

The University points out that it is working in partnership with various agencies to keep the disruption to a minimum.

It is expecting around 20,000 people on Friday, 11 September and Saturday, 12 September, probably with more arriving on the Saturday than on the Friday.

All visitors will be directed to enter through the West and North entrances. There will also be a shuttle bus running throughout both days from the railway station to the Jubilee Campus and University Park.

## VOLUNTARY CONTROL OF LETTING BOARDS UPDATE

THE FINAL SCHEME CAME INTO OPERATION ON THE 1 JUNE AND MONITORING STATED ON THE 1 JULY. NAG MEMBERS ALONG WITH UNIPOL, COUNCIL OFFICERS and representatives from community organizations will continue to monitor the scheme monthly until Spring 2010.
