Lenton Abbey Family Fun Day

The small group of volunteers have been busy preparing for the Fun Day on Saturday 7th July, 1-5. If you would like to help on the day you would be very welcome, please get in touch.

L5 Bus

Passengers are concerned that the L5 bus has been delayed recently on its progress around Sutton Passey's Crescent, due to inconsiderately parked cars. We have discussed this with Nottingham Community Transport, who operate the service, and they do not see the problems as particularly serious, although obviously we need to ensure the bus runs to timetable. We have asked Community Protection and Parking Services to monitor the situation and take appropriate action where necessary. If the situation does not improve we will consider putting a parking restriction down one side of the road. We would ask residents to think about bus access when parking. Please get in touch if you have any comments.

Crime and Anti-Social Behaviour

Please be aware that crime has risen recently in the ward and, in this hot weather it is very tempting to leave doors and downstairs windows open. Please be careful not to give opportunities for easy pickings!

The Police have reported some anti-social behaviour in parts of Lenton Abbey and we have asked for a few trouble spot alleyways to be gated as soon as possible.

We have received some complaints about noisy parties. If you are suffering from unreasonable noise please report it on 101 and Community Protection will take action.

Railings

We have had damage to railings in Enderby Square and Farndon Green. The repair of these railings is the responsibility of Nottingham City Homes. We are very grateful for their swift response and repair in Farndon Green, and are still awaiting action in Enderby Square.

Licensing of Private Rented Properties

If you live in a private rented property you will be particularly interested to know that Selective Licensing of properties other than HMOs will begin on 1st August. This means that landlords will have to ensure that their properties meet certain standards and will be liable for inspection. The Council is also consulting on the renewal of the Additional Licensing of HMOs. It is important that local people have their say so please comment here:
